## Enhanced Life Safety Criteria-City of D'iberville Short Term Rental

The following code related items shall be brought into compliance as part of the change in occupancy requirements in conjunction as part of the short-term rental process.

Additional, location-specific Building Code requirements may apply.

Before any occupancy inspection is scheduled, please make sure the following items have been addressed for compliance. Someone must be present at the time of inspection.

- Address clearly displayed on the outside of the building. This must be visible from the street. In locations not visible from the street, a pilaster or signage must be placed at the street-not to exceed 1 square foot.
- Type 2A 10BC fire extinguisher-placed in a location visible to the occupants and mounted to the wall. Note-maximum travel distance to a fire extinguisher if 75 feet-additional extinguishers may be required on each floor.
- All electrical main and distribution panels must have all circuits labeled properly.
- Smoke detectors must be installed in all sleeping areas and all corridors leading to the sleeping areas. If the building has gas service, all locations must also include Carbon Monoxide Detectors (outside bedrooms). All these devices must be wired in sequence. Garages if they are attached to the main structure, must also include a Carbon Monoxide Detector.
- Adequate garbage receptacles and storage location.
- Stove must have anti-tip device installed.
- All sleeping rooms must have a secondary means of egress, operable window or second door leading to the exterior. In 2 story structures, an emergency egress ladder must be provided.
- During the inspection, no exposed wiring will be allowed. All wiring must be enclosed within conduit.
- All electrical outlets located within 6' of any water source must be of GFCI type or the circuit must be GFCI protected.
- Any building changing their occupancy to R-1 as part of the permitting process for short term rental use, must be evaluated for code compliance in accordance to the 2018 International Fire Code, 2018 International Existing Building Code and the 2018 International Building Code. Every structure will be reviewed for the Occupancy type(s), Construction type(s), Means of egress and Life safety requirements based on the above listed codes.
